What are the changes?

1. General Insurance Transfer

Australian Alliance Insurance Company Limited, the company that currently underwrites the above Apia branded general insurance policies, will transfer its general insurance business to a related company, AAI Limited ABN 48 005 297 807 (AAI) by way of a scheme under the *Insurance Act 1973* (Cth), which has been confirmed by the Federal Court of Australia.

In the months before the Court confirmed the scheme, Australian Alliance Insurance Company Limited undertook steps (including but not limited to newspaper and internet advertising, information included in regular operational correspondence and email communications) to bring the then proposed transfer to the attention of policyholders.

The scheme will take effect on and from 1 July 2013, or such other date agreed by AAI and Australian Alliance Insurance Company Limited and approved by the Court (the **Effective Date**) and is one of four schemes which are occurring simultaneously as part of an internal reorganisation.

On and from the Effective Date:

- AAI will become the underwriter of all Apia branded general insurance policies issued by Australian Alliance Insurance Company Limited and will settle all claims under those policies;
- AAI will issue Apia branded general insurance policies (and PDSs for those policies);
- all references to Australian Alliance Insurance Company Limited ABN 11 006 471 709 AFSL No. 235011 (however that company may be referred to) in the PDS, and any other SPDS that you have been given for your PDS and in your policy documents (including your policy schedule or certificate) will be a reference to AAI Limited ABN 48 005 297 807 AFSL No. 230859; and
- Australian Pensioners Insurance Agency Pty Ltd
 ABN 14 099 650 996 will cease to be the agent and authorised
 representative (No. 239591) of Australian Alliance Insurance
 Company Limited ABN 11 006 471 709 AFSL No. 235011 and
 will become the agent (acting under a binder) and authorised
 representative (No. 239591) of AAI.

All policies issued / contracts of insurance entered into:

- before the Effective Date will be issued by and entered into with Australian Alliance Insurance Company Limited and will be transferred to AAI on the Effective Date; and
- on or after the Effective Date will be issued by and entered into with AAI.
- 2. Changes to each PDS with effect from the Effective Date
- a) The contact address in the section 'This insurance product is issued by' on the inside front cover and on page 4 under the heading 'About the insurer' is changed from 'Level 4, 440 Collins Street, Melbourne, VIC 3000' to 'GPO Box 756, Melbourne, VIC, 3001.'
- b) The paragraph under the heading 'How are we paid for providing the financial services' on page 5 of the PDS is deleted and replaced with the following:
 - 'AAI and other Suncorp Group companies provide Apia with the resources it needs to provide the financial services. These services are provided on behalf of Apia by staff employed by the Suncorp Group of companies. In addition to their salary, staff may receive bonuses if they achieve their performance targets. You will not be charged an additional fee as a direct result of this.'

There is no action required by you in respect of these changes.

How you deal with us remains the same.
